Example: Designer M contracts with a law firm in Lake Placid, New York (Essex County), to design the interior of a satellite office it plans to open in Burlington, Vermont. The two that are most relevant to an interior design business are C corp, which is a legal entity that is completely separate from its owner, and S corp, which is similar to a C corp, but is designed to avoid the double tax on income, personal and corporate, that occurs for owners of a C corp.
