The Workforce Incentive Program (WIP) - Practice Stream began on 1 February 2020 as part of the 2018/2019 Stronger Rural Health Strategy. It aims to build a sustainable and high quality health workforce, particularly in rural and remote areas, by better targeting incentives.

The Practice Incentives Program (PIP) encourages general practices to continue providing quality care, enhance capacity, and improve access and health outcomes for patients. We administer PIP on behalf of the Department of Health. PIP has 8 individual incentives under 3 payment streams.

Practice Incentives Program - Services Australia

The WIP also provides financial incentives to support general practices to engage the services of nurses, Aboriginal and Torres Strait Islander Health Practitioners and Health Workers, and eligible allied health professionals. From early 2020, general practices and doctors participating in the Practice Nurse Incentive Program (PNIP) and the General Practice Rural Incentives Program (GPRIP) will automatically transition to the WIP.

A practice or individual PCP within the PCMH Program is required to have an open Practice unless they are closed to all payers. The incentive payment amount depends on practice size and the hours worked by the health professionals at the practice. A rural loading is applied on top of WIP - Practice Stream incentive payments in recognition of the difficulties rural and regional areas face attracting and retaining health professionals.

About the new Workforce Incentive Program for general practice

The proposed restructure of the Practice Incentives Program (PIP) was announced by the Federal Government as part of the 2016-17 Budget and involved scrapping a number of incentives including the procedural general practitioner payment, the general practice aged care access incentive and service incentive payments for diabetes care, asthma care and cervical screening. Funding would instead be redirected to the implementation of a new quality improvement practice incentive (QI PIP).

There is an incentive structure built into the program to encourage you to precept the maximum number of rotations allowed under this legislation. Physicians can earn a maximum of \$8,500 in credits; APRN and PAs can earn a maximum of \$6,375 in credits.
