There is a statutory national minimum wage in Turkey, which is set as an amount that is applicable to all employees. Employers cannot provide lower salaries to their employees than the national minimum wage. From January 1, 2020, the national minimum wage is gross TRY 2.943,00 per month.

The main legal instrument of labor law is the labor contracts which govern the rules between the employee and the employer. According to Turkish law, labor contract must encompass three necessary elements. These elements can be mentioned under the titles of technique, economic and legal. As regards to technical feature of labor contract, in the contract there must be provisions regulating the rules of the business and clarifying the essence of the employment.

The Turkish Labor Law sets a minimum wage, which is checked against inflation once or twice a year. As of 01.01.2015, the gross monthly minimum wage is TL 1201,00 (approximately, \$461).

In Turkey, all employees are entitled to have a paid annual leave with the condition of completing minimum one year of service (including trial period) in the workplace. The right to annual leave with pay cannot be waived. Turkish Labor Law regulates the conditions, length and the application of annual leave under the articles between 53 and 61.

Statutory leaves under Turkish labor law - Expat Guide Turkey

The Act has special child-labor regulations that apply to agricultural employment; children under 16 are forbidden to work during school hours and in certain jobs deemed too dangerous. Children employed on their families' farms are exempt from these regulations. The Wage and Hour Division administers this law. OSHA also has special safety and health standards that may apply to agricultural operations.

Turkish child labor law sets the minimum age for part-time employment at 13, on condition that it is not hard physical labor and they continue to attend school, and the minimum age for full-time employment at 15.
